RULES AND REGULATIONS

I. <u>Rules and Regulations for the Government of Water Utilities</u>, adopted by the Public Service Commission of West Virginia, and now in effect, and all amendments thereto and modifications thereof hereafter made by said Commission.

APPLICABILITY

Applicable within the entire territory served.

AVAILABILITY

Available for general domestic, commercial and industrial water service.

(I) RATES *

First	3,000	gallons used per month	\$17.21 per 1,000 gallons
Next	3,000	gallons used per month	\$16.67 per 1,000 gallons
Next	4,000	gallons used per month	\$15.71 per 1,000 gallons
Next	10,000	gallons used per month	\$14.99 per 1,000 gallons
All Over	20,000	gallons used per month	\$14.27 per 1,000 gallons

(I) MINIMUM CHARGE *

No bills will be rendered for less than the following, based on meter size:

5/8	inch meter	\$	33.14 per month
3/4	inch meter	\$	49.72 per month
1	inch meter	\$	82.86 per month
1-1/	½ inch meter	\$	165.70 per month
2	inch meter	\$	265.12 per month
3	inch meter	\$	530.24 per month
4	inch meter	\$	828.50 per month
6	inch meter	\$1	,657.01 per month

(D) The above charge is subject to an additional \$6.16 per 1,000 gallons of water used per month.

DELAYED PAYMENT PENALTY*

The above schedule is net. On all accounts not paid in full when due, ten percent (10%) will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

RECONNECTION FEE - \$20.00

To be charged whenever the supply of water is turned off for violation of rules, non-payment of bills or fraudulent use of water.

(I) PRIVATE FIRE PROTECTION *

Annual private fire service fee of \$228.37 for all unmetered private fire service connection lines.

TAP FEE

The following charge is to be made whenever the utility installs a new tap to serve an applicant.

A tap fee of \$300.00 will be charged to all customers who apply for service outside of a certificate proceeding before the Commission for each new tap to the system.

(D) LEAK ADJUSTMENT *

\$8.76 per 1,000 gallons is to be used when the bill reflects unusual consumption which can be attributed to eligible leakage on the customer's side of the meter. This rate shall be applied to all such consumption above 200% of the customer's historical usage.

RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the water utility up to a maximum of \$25.00 will be imposed upon any customer whose check for payment of charges is returned by the bank due to insufficient funds.

SECURITY DEPOSIT

Not to exceed two times the average monthly bill for the applicant's specific customer class or fifty dollars, whichever is greater. This fee may be changed by applicable statutory provisions.

(I) * 9.58% CASH WORKING CAPITAL RESERVE INCREMENT

9.58% of total billings at the indicated rates is required to be recorded as a credit to "Miscellaneous Operating Reserves", with related collections to be charged to "Other Special Funds" and deposited into a distinct CWCR Bank Account.
